#### **GENERAL VESSEL INFORMATION:**

2000: The container ship **AKSOY TRUVA** arrived at Lyttelton on 13th September 2000. She commenced loading coastal cargo on 14th September and made her first call at Tauranga on 16th September and at Auckland on 17th September.

She operated her first few round trips still under the name of AKSOY TRUVA whilst approval for renaming her

**SPIRIT OF ENTERPRISE** was awaited from Istanbul. In fact she was still officially named **AKSOY TRUVA** until 16th November, but was causing confusion by sailing around calling herself **SPIRIT OF ENTERPRISE** at port control stations and appearing as such on port arrival schedules. After renaming as **SPIRIT OF ENTERPRISE** she was registered at Lyttelton.

Turkish-built at the Gelibolu shipyard, Gelibolu (Gallipoli), her certificate of registry was issued on 10th May 1999. She is owned by Ali Riza Aksoy Denizcilik, and operated by Ufuk Denizcilik. (Internet New Zealands Maritime News Nov 2000)
