The abandoned 1996-built VLCC 'Samho Crown' is to be auctioned in Dubai on Sunday at a reserve price of around \$22 mill.

It is currently lying between Port Rashid and Dubai Drydocks in the UAE.

South Korean Samho Shipping, the company that is alleged to own the vessel was believed to have gone into liquidation in 2012. It was said to be the same company that paid a \$9 mill ransom to Somali pirates in 2010.

The Marshall Islands flagged vessel was built by Hyundai Heavy Industries at Ulsan. She has been lying at Dubai since 2011.

Samho creditors secure \$20.8m for tanker demolition candidate

Pakistan has emerged as the final destination of a VLCC that has been sitting idle off Dubai for nearly four years.

According to GMS the 300,500-dwt Samho Crown (built 1996) was sold "as is" at auction for \$490 per ldt, which amounts to a payday of approximately

Legal dispute involving owners of MT Zoya 1 supertanker holding up salary payments with crew unable to come ashore



Desperate sailors have spoken of how they have been trapped on board a supertanker 17 kilometres off the coast of the UAE because of a legal dispute involving the ship's owners.

Sixteen Indian and Pakistani crew have been on the 330-metre MT Zoya 1 for up to a year, awaiting coastguard clearance to come ashore.

Because of an unspecified legal dispute with the owners of the vessel, crew have been mostly unpaid since December and have been given no information when they will be rescued from the ship.

Although the crew is receiving regular fresh supplies, they say they are not being allowed to leave until all disputes have been settled.

Lawyers acting on behalf of the ship's owners claim *MT Zoya 1* has been unlawfully arrested outside port limits following a claim filed at Sharjah courts by a Swiss bank.

The legal claim relates to an unpaid loan by a third party, but the parties involved said they could not discuss the matter any further while it is in court.

Charterers Avantgarde Petroleum, part of ECB International, the ship's owners, said it is trying to support the men and hopes to have the arrest order lifted soon.

As the ship is anchored outside of the UAE immigration jurisdiction, a crew change has not been possible.

The vessel has been anchored off Sharjah since October 2016 according to crew, who have said it is in need of repairs before it can return to service.

Mystery surrounds ownership of VLCC hit by blaze off UAE

Zoya I owners are untraceable and the ship has not moved in over three years

The blaze-hit VLCC Zoya 1 appears to be something of an enigma in the VLCC sector as little is known about its owner Ullib Shipping

An out-of-use VLCC caught fire yesterday 21 nautical miles northwest of Dubai.

Splash understands the Zoya 1, which has not traded for the last three years and has seen its crew face appalling conditions onboard, was having its tanks cleaned in preparation for scrapping when the blaze broke out yesterday.

The ship has been at the centre of a three-year legal dispute with local Dubai newspapers describing the plight of the abandoned crew onboard. The crew were evacuated yesterday as the fire grew in intensity. The 1996-built ship had no cargo onboard when the fire started.

Tanker was reported on fire off Sharjah, UAE, in the afternoon Jan 29. Reports went with video footage and photos, but all being taken too far from the ship. It's obviously a tanker, a big tanker with that, anchored and in ballast. Later unconfirmed information identified tanker in question as VLCC ZOYA 1, operated by UAE company. Tanker in ballast is anchored off Sharjah since at least year 2018, due to financial and legal disputes, including unpaid crew wages. It is highly likely, that the ship has on board some watchmen at best, not regular crew. Or maybe tanker is unmanned. Obviously, gas in empty tank or tanks somehow inflamed, maybe igniting residues in tanks bottom part.

Crude oil tanker ZOYA 1, IMO 9081174, dwt 300482, built 1996, flag Panama, manager AURUM SHIP MANAGEMENT FZC, UAE (EQUASIS).

According to Gulf News, tanker is presently under the name of SAM, Palau-flagged, preparing for final voyage to India's scrap yard, for dismantling.
