2002: TSAKOS Energy Navigation is adding more newbuildings to its tanker fleet with an order for up to four more suezmax units from Hyundai Heavy Industries. Already this year TEN has already taken delivery during 2003 from HHI, of the 165,000 dwt crude oil tankers SILIA T, **DECATHLON**, PENTATHLON & TRIATHLON.

2003: The Suezmax tanker was sold by Tsakos Shipping & Trading S.A. (TEN), to Emissionshaus Salamon AG, Dortmund (investment company) for US \$ 55 mio and has been chartered back for 5 years (US \$ 23500 per day) by TEN. ((AK 09+10/2003)

October 8, 2003 - Tsakos Energy Navigation Limited (TEN) (NYSE:TNP) today announced the sale of the suezmaxes **DECATHLON** & PENTATHLON. Both vessels will be time chartered back to TEN for a period of five years, with options for extension.

**DECATHLON** & PENTATHLON are two of four suezmax sisterships delivered in 2002 to TEN from the Hyundai Samho shipyard in Korea. The sale price results in a combined net profit of over \$15 million, which will be amortized over the 5-year period of the charter back. As announced earlier this month, both the **DECATHLON** & PENTATHLON have been chartered at attractive rates to Petrobras, a state oil company. Each contract commenced at the beginning of October, 2003 extending for three years at a fixed rate for the first contract and a minimum rate for the second contract, with the opportunity for profit sharing if the prevailing spot market dictates.
