Hamburg shipowner Claus-Peter Offen has hit the acquisition trail with the takeover of Munich-based Conti Holding, formerly one of Germany's premier shipping KG houses.

Further, it is set to secure management contracts for another circa 20 container ships, which were placed with Conti's other ship management outfit, NSB Reederei.

Although NSB was already given notice (of cancellation) on the management contracts for the 20 Conti ships early this year, the company still hopes to negotiate a renewal of the contracts perhaps as sub-contractor to the Offen Group, an NSB representative told *Fairplay*.
