GENERAL VESSEL INFORMATION:

Another incident occurred on the Humber today as an inexperienced ABP pilot failed to appreciate the strength of the tide. At 0716 the 10,000 tonne liquefied gas tanker "**KEMIRA GAS**" and her tug "LADY LAURA" were involved in a collision with the Sand End Light Float. The ABP pilot on the KEMIRA GAS had asked the tug to make fast at the stern (rear) of the vessel. Unfortunately the

pilot had not informed the tug that KEMIRA GAS had just collided with the Sand End Light Float and that the float was brushing down the side of the ship. By the time the tug could see the float it was too late. LADY LAURA had no chance to take avoiding action and collided with the Sand End Float causing, we understand, damage to the tug which has still to be assessed. KEMIRA GAS is a regular visitor to the Humber and carries liquid ammonia. The collision occurred less than half a mile from the small town of Paul.
