

# 2021: ALPHATANKER

US sanctions more tankers over Venezuela. In one of its final acts, The Trump administration has announced that six tankers and three shipping companies have been sanctioned over their links to facilitating the export of Venezuelan oil. Three of the tankers, the 76,000 dwt Balita, the 146,270 dwt Domani and the 150,000 dwt Freedom, are managed by Ukraine-based Fides. Ship Management, while a fourth, the 105,600 dwt Baliar was managed by the firm until November 2020. The other two tankers sanctioned are the 321,000 dwt Maximo Gorki, owned by Venezuela's water authority INEA and the 105,340 dwt Sierra, owned by Russian firm Rustanker.
