The "**ADY**" was the "BELL ADY" when the Bell-lines exists. Bell Lines has chartered the vessel by the Cyprus subsidiary Bell Transport Services Ltd. Bell is now out of business and their ships are still used on the same routes as Bell had before. She's owned by a German shipowner and bears the flag of Antigua&Barbuda. She's built in 1995 in Germany. The "**ADY**" is sailing between Rotterdam, NL and Hull, UK.
