GENERAL VESSEL INFORMATION:

Rederi AB Donsötank is a Swedish shipping company with a fleet consisting mainly of chemical and product tankers. ESL Shipping Oy of Finland is a leading carrier of dry bulk cargo in the Baltic region. Together these two companies own the 19,625 dwt geared general cargo carrier **CREDO**. The ship will trade in the Baltic and is being built to Finnish ice class 1A Super.

MS Credo will be commissioned shortly from Shanghai Edward. She will be the second vessel in the Eira class.

ESL Shipping Ltd, an Aspo Group company, has signed an agreement to form a joint venture with the Swedish Donsöshipping. The joint venture will order a new vessel from China. The new vessel is a dry bulk cargo ship of about 20,000 dwt corresponding in size to our previous newbuilding, the ms Eira, launched in 2001.

The vessel will be designed specifically for ESL Shipping's dry cargo transports in the Baltic Sea area and it will be built to meet the highest Finnish ice class - 1A Super. The total value of the investment is approximately EUR 22 million. We expect the ship to be commissioned 2006.

The 21,353-DWT bulk carrier "**CREDO**", owned by Swedish Donsotank (65%) and Finnish ESL Shipping (35%), has been delivered from Shanghai Edwards shipyard, China.

The vessel will leave for Taiwan to pick up a load of steel-coils destined for Muuga in Estonia.

"Credo" will be operated by ESL Shipping in its dry cargo transports in the Baltic Sea area.
