Borealis makes first move into boxships. The London-based investment firm has emerged as the buyer of the 1,730-teu

WEHR RISSEN (built 1999) for a reported \$6.6m, in a deal that could mark a significant improvement in the market for smaller containerships. The Oskar Wehr-managed, Hansa Treuhand-owned vessel has fetched a price nearly 10% higher than a sistership sold in June and 60% above the amount another sistership fetched earlier this year. The deal involving the geared, Polish-built vessel includes a six-month time charter to Pacific International Lines (PIL) at \$7,500 per day.
